DIRECTIONS FOR USE

Before using this product, food products and packaging materials must be removed from the room or carefully protected.

FOR USE AS A ONE-STEP DISINFECTANT, VIRUCIDE*: 1. Pre-clean heavily soiled areas. 2. Apply this ready to use product jundiluted to disinfect hard, non-porous surfaces with a sponge, brush, cloth, mechanical spray device. For spray applications, spray 6-8 linches from surface. Do not breathe spray. 3. Treated surfaces must remain wet for 10 minutes. 4. Wipe dry with a clean cloth or allow to air dry. Rinsing of floors is not necessary unless they are to be waxed or polished. 5. Change solution daily or when visibly dirty.

FOR USE AS A GENERAL CLEANER AND/OR DEODORIZER: Apply ready to use product undiluted to hard, non-porous surfaces. Wipe up lexcess liquid or allow to air dry.
